General Manufacturer Warranty

All items produced by Goman are covered by the standard warranty Legal European 2 year limited for lack of conformity required by the Consumer Code (Legislative Decree Nr.26 of September 6, 2005) from the date of issue of the invoice. Warranty does not cover damage caused by misuse or improper installation and we accept no responsibility for any direct or indirect damages resulting from improper use of the products we manufacture.

Extended Warranty

Goman reserves on specific articles to grant an extended warranty with respect to the convention legal. The simple wear and tear is excluded from the guarantee.

For lack of conformity means: in accordance with Article 129 of the Consumer Code, the product presents lack of conformity if it is not fit for use which are normally used products of the same type, if it is not in conformity with the description of the manufacturer terms of quality or performance, or if it does not have the quality or performance which are considered normal in goods of the same type, which buyer can reasonably expect given by the nature of the product. It is therefore necessary, before the use and / or installation, carefully read the instruction booklet, "Use and Maintenance" included in the package.

The warranty guarantees the buyer the possibility of free supply of spare parts or the complete replacement of the non conformed piece only if the request is done to the supplier within 2 months from the date of its installation and within the 2 years warranty. In the eventuality the piece to be replaced is not any more available, Goman reserves the right to supply an equivalent piece.

The products must be installed according to the installation instructions supplied and taking into account the characteristics of structures and plumbing available. The warranty does not cover:

- Damage or injury caused by inadequate cleaning (see instructions for care and maintenance)
- Because of mould, scale, corrosion and natural change in color
- The breaking glass materials and consequential damages

In the case of not ascertained lack of non conformity the buyer will have to bear the cost of call and any other costs arising.

In case of failure of the product: consult the instruction booklet to ensure that the defect can be solved with the proper application of the functionality of the product itself. Ascertain that the fault is within the type of anomalies covered by insurance; otherwise the cost of the intervention will be at full responsibility of the purchaser.

Are considered documents which could prove the purchase by the end customer: Sales receipt, Invoice issued by the dealer, Bill or DDT issued by dealer, Installer's invoice to the final customer or purchase document issued by the dealer to the installer if bearing the specific description of the product and the name and, if possible, address of the end customer.

Important note before the installation of the product:

It is not assured any guarantee for any damage or defect when installation is completed. This is why we ask you to care fully examine the product before installation to ensure it has not suffered any damage or shows any defect of conformity.


